NOTICE

In adherence to JBE Proclamation 2020-59, the FRS board chairman ruled that all mandatory FRS board meetings will be held <u>in-person</u> until further notice. In further adherence thereof, the number of persons allowed in the building is limited to 25% capacity until June 5th, and 50% capacity thereafter, but only if Governor Edwards issues an updated proclamation authorizing implementation of Phase II of the COVID-19 recovery plan. The maximum capacity of the entire FRS building is 70 persons, including board members and employees. Based on a ratio comparing the square footage of the board room to the overall square footage of the FRS building, the maximum capacity of the board room is 35 persons. Applying the 50% capacity limitation of Proclamation 2020-59 means only 18 people can occupy the board room at one time. Board members and employees attending the meeting equal 15 persons, thereby leaving only a 3-person capacity available for visitors attending the meeting. Visitors are seated on a first come, first served basis. These limitations apply until such time as additional capacity is authorized by the Governor. Masks are required while in the building. The temperature of each person entering the building will be taken and anyone with a fever of 100.4 or above will not be allowed admittance.

The public may attend the meeting by teleconference. Based on the following instructions, members of the public have the choice of attending by audio or video-
