NOTICE

In adherence to Section 2(E) of Governor Edward's Proclamation No. 168 JBE 2020 (copy attached) regarding Modified Phase 2 of Resilient Louisiana, the capacity limitations are restricted to 25% occupancy, with a maximum of 75 people in any indoor space at the same time, with social distancing, all enforceable by the Louisiana State Fire Marshal. The availability of seating is on a first-come, first-served basis.
