## NOTICE

In adherence to Governor Edward's Proclamation No. 17 JBE 2021 and 18 JBE 2021 (copies attached) regarding the current Phase of Resilient Louisiana, and in conjunction with the Open Safely requirements, effective 03/03/2021 (copy attached) the capacity limitations are restricted to a maximum building occupancy of 75% and, for conference rooms, a limitation of 15 persons or the maximum number of persons that will allow for a 6-foot distance to be maintained between unrelated small groups, with social distancing and mandatory facial covering, all enforceable by the Louisiana State Fire Marshal. The availability of seating is on a first-come, first-served basis. Unfortunately, because of these mandatory restrictions, any visitor arriving after capacity has been attained will not be allowed to enter unless or until seating becomes available. The temperature of each person entering the meeting room will be taken and anyone with a fever of 100.4 or above will not be allowed admittance.

As an additional public service, the meeting will also be made available by audio/video teleconferencing. Any person (including the public) can attend by teleconference and submit comments regarding matters on the agenda.
