An election will be held between now and March 6, 2025, for one five-year term of office as member of the retirement system's Board of Trustees.

Any member that is <u>retired</u> as of March 6, 2025, from a participating employer is eligible to run for the seat on the Board.

Candidates for election to the Board must be nominated by the petition of at least ten (10) retired members of the system. A Nomination Petition may be obtained by downloading it from our website (www.lafrs.org) or by calling our office. To be valid, each nomination petition must be completed <u>in full</u> and must be received in the retirement system office <u>NO LATER THAN 4:00 P.M. ON JANUARY 17, 2025.</u> The candidate information form and the signed memorandum of responsibility for board members must be attached to the nomination petition.

The ballot will list in alphabetical order by last name each qualified candidate, his/her previous job position/title and employer. No other information other than the candidate questionnaire concerning any candidate will be printed on the ballots or distributed by the retirement system office. The retirement system office will not provide any information concerning the retirement system membership to a candidate.

THE RETIREMENT SYSTEM WILL NOT DISTRIBUTE ANY MATERIAL, INFORMATION, PUBLICITY, RECORD, DESCRIPTION, STATEMENT OR COMMUNICATION OF ANY TYPE ON BEHALF OF OR IN RELATION TO ANY CANDIDATE.

Page 2 Election to Board of Trustees December 16, 2024

Ballots must be returned to the Office of EisnerAmper LLP by 4 pm on March 6, 2025 in order to be included in the voting process. A pre-stamped and addressed envelope is provided with the ballot for ease of participation in the election. Ballots must be returned in the pre-stamped envelope.

The candidate who receives the majority (greater than 50% of the members voting) of valid votes will be declared to be the winner of the election and will be announced at the meeting of the Board of Trustees on March 13, 2025. If there is not a majority winner, a runoff election will be held between the two candidates receiving the greatest number of votes.

A recap of the requirements for the nomination packet to be considered valid is listed below. If any of the required information **is not** included when submitted to the retirement system office by January 17, 2025, the nomination will be marked incomplete and invalid.

- 1. Candidate Information
 - a. The candidate for election must be retired (have an effective date) no later than March 6, 2025
 - b. Must be attached to the Nomination Petition and returned by 4 P.M. on January 17, 2025
- 2. Nomination Petition
 - a. The candidate for election must be retired as of March 6, 2025.
 - b. Must contain signatures from at least 10 retirees nominating an individual to the Board of Trustees
 - c. The retirement system office will verify the membership of the retirees signing the petition
 - d. Must be received in the Retirement System Office by 4 P.M. on January 17, 2025
- 3. Memorandum of Responsibility
 - a. Must be signed and returned with the Nomination Petition by 4 P.M. on January 17, 2025

Memorandum of Responsibility for Board Member

Thank you for your offer to participate in the governance of your retirement system. The Firefighters' Retirement System (FRS) was established in 1979 by the legislature and the governing authority was placed with the Board of Trustees.

- As a member of the Board, you will be responsible for setting the policies of the system for all members and be responsible for the proper investment of the system's \$2.5 billion portfolio.
- Each member of the Board is a fiduciary (R.S. 11:261) and as such you are bound by the "Prudent Man Rule", which means you, as a Board Member, are required "... to act with the care, skill, prudence, and diligence under the circumstances prevailing that a prudent institutional investor acting in a like capacity and familiar with such matters would use in the conduct of an enterprise of a like character and with like aims." (R.S. 11:263) "A fiduciary must discharge his duties within the law solely in the interest of system members and beneficiaries for the exclusive purpose of providing benefits to participants and beneficiaries and paying the expenses of administering the plan." (R.S. 11:264.4)
- Each member of the Board is required to file a Tier 2.1 Personal Financial Disclosure Statement annually on or before May 15 with the Board of Ethics.
- The Board of Trustees for FRS typically meets in Baton Rouge. A schedule of the 2025 meetings is attached. The meetings start at 8:30 a.m. and continue until all business is completed.
- According to R.S. 11:185, each member of the Board of Trustees shall annually attend at least eight (8) hours of investment training, four (4) hours of actuarial science information education, two (2) hours of education regarding the laws, rules, and regulations applicable to his/her system, and two (2) hours of instruction on fiduciary duty and ethics. No new board member shall be permitted to vote on any matter until he/she has completed the fiduciary and ethics requirement and one hour of education in each of the other required areas.
- Board members have a very important responsibility, which at times can become time consuming, and for their time and trouble, the legislature authorizes the system to pay them \$75 per day, plus expenses.
