Dear Members,

We are pleased to present the March 31, 2018 Private Equity Report for the Firefighters' Retirement System of Louisiana. The report provides a variety of performance analysis for the overall portfolio. The reports include trailing performance, performance by investment stage and vintage year performance.

The Firefighters' Retirement System of Louisiana experienced a positive quarter, having a nominal IRR of 0.40%. The IRR since inception is 1.17%. The overall multiple (current valuation plus cumulative distributions, divided by total capital calls) is 1.05.

The following table presents the status of the Firefighters' Retirement System of Louisiana private markets portfolio as of March 31, 2018:






As of March 31, 2018, the Firefighters' Retirement System of Louisiana had commitments totaling \$199.73 million to 13 private markets fund. Of the 13 funds in the private equity portfolio, 3 are in the investing stage, 6 are in the harvesting stage, 1 is liquidating, and 3 have been completed. The following chart illustrates the commitment history of the Firefighters' Retirement System of Louisiana private markets program through the quarter end:




The following chart provides an analysis of the vintage year performance comparing the capital calls to the distributions and reported value:




During the quarter-ended March 31, 2018 4 funds in the Firefighters’ Retirement System of Louisiana private markets portfolio drew capital and 6 funds made a distribution. The summary of the cash flow follows:

Since inception the private markets program has gained \$8.69 million in value for the Firefighters' Retirement System of Louisiana. Mezzanine added \$6.94 million, Fund of Funds added \$2.67 million, Buyouts added \$4.11 million and Secondaries added \$4.02 million. Venture has lost (\$9.05) million.



As of March 31, 2018, the 13 private markets funds in the Firefighters' Retirement System of Louisiana portfolio had the following investment strategy diversification by the investment fund's reported value:
